

## STATE OF POLICE SERVICE

In 2014 the Rock Falls Police Department responded to 19,447 "calls for service", of those, 281 were motor vehicle accidents. The department received a total of 4,954 "E911" calls.

In comparison in 2013 the "calls for service" totaled 17,472 of those, 305 were motor vehicles accidents. The department received a total of 3,963 "E911" calls.

With the patrol section of the department at 90% staffed the overtime was up in some areas due to the lack of staffing and coverage. Unexpected city events created an increase in overtime also. Court overtime was down. The Telecommunication section was at 80% staffed and the overtime has increased substantially to handle the shift coverage.

In Patrol, one officer retired, one officer left for another police department and another officer was off on worker's compensation injury for the majority of the year. In Telecommunications, one telecommunicator retired after 34yrs.

We continue to stress the need for continuous training. The total training hours for the year was 957 hours. This is 700 hours under last year's training.

With the continuing change to laws, increases to urban and rural crimes, the department needs to stay abreast of training needs for the officers and Telecommunicators. This will result in an increase in the training budget because more classes are being held further away which requires hotels, meals and registration fees.

This is a major concern within the department, however I believe we can continue to provide the services the citizens of Rock Falls expect and deserve.

## **Staffing Status:**

As of December 31<sup>st</sup> 2014 the department was staffed with nineteen sworn officers and seven telecommunicators and one part-time records clerk. The department's full staffing level is twenty sworn officers and seven telecommunicators. The newest two officers were hired on December 29<sup>th</sup>. They will be attending the Academy starting January 5<sup>th</sup> and will graduate March 20<sup>th</sup> 2015. The department will start the hiring process on January 5<sup>th</sup> to replace Officer Garrison's vacancy.

In the early spring of 2014 Officer Nicholas Butler voluntary resigned from the department.

Two telecommunicators were hired but both resigned within a month of being hired for other employment. Jennifer Hendricks was hired to fill the vacancy of T/C

In the summer of 2014 Community Service Officer/Telecommunicator Joan Atilano retired after 34 years of dedicated service to the Department and the city. Telecommunicator Amy Stoeckel was appointed to fill the vacancy. Autumn Day was hired to fill the Vacancy of T/C left by Amy Stoeckel.

In the fall of 2014 Sgt. John Worcester retired after 20 years of dedicated service to the Department and the city. With John's retirement Detective Veronica Jaramillo was promoted to Patrol Sergeant and Patrolman Dave Pilgrim appointed to Detective and moved into investigations.

In the fall of 2014 with the movements and retirements three new officers were hired. Officer Matt McKanna, Officer Greyson Scott and Officer Nicholas Neblung. This brought the department to full staffing of sworn and non-sworn personnel.

On December 31<sup>st</sup> 2014 Officer Steve Garrison accepted a patrol position with the Dixon Police Department.

In the year of 2014 we have hired four new officers to replace those who have left and or retired. We have hired four telecommunicators but only two have remained. The department was fully staffed at the end of the calendar year but is now down one officer. The department will start the hiring process in January to replace Officer Garrison on January 5<sup>th</sup> 2015 in an attempt to bring the department to full staffing.

The department is very young in years of experience. There are now eight sworn officers under five years of service. There are three telecommunicators under two years of service. They all are very competent and proud to be members of the Rock Falls Police Department.
